

# Face Painting by Fancy CONTRACT

Initial each page, sign the last one and **mail the contract back** (address shown at the bottom of each page). The non-refundable deposit is \$40.00 for an event and \$50.00 for a class. I will sign the contract and return a copy of the contract to you. The signed contract should be returned within 5 days to secure the entertainment, date and time for your event.

If more children (or adults) attend the party than are expected, and artist does not have another booking to attend, artist will stay as long as you wish at the agreed upon hourly rate. Artist cannot be held responsible for the number of children at your event.

The artist may take a short break after 3 hours.

**Directions** - The client must provide proper address with zip code and/or directions.

**Equipment** - Sturdy table (TV tables & card tables are not acceptable). Two sturdy folding style chairs or sturdy stools (Chairs with arms and lawn chairs don't work well).

**Face Painters** - Cannot be set up in direct sunlight as extended exposure to sunlight causes the face paint to rapidly degrade; they require a shaded and protected location.

**Balloon Twister** - Cannot be set up in direct sunlight as extended exposure to sunlight causes the balloons to rapidly degrade; they require a shaded and protected location.

**Balloons** - Client agrees to keep balloons away from children less than three years of age, as balloons can present a choking hazard to young children, and acknowledges that artist will NOT give balloons to children under three years of age. Client agrees that if any disputes arise, the artist(s) have the final say over who will or will not receive balloons. Example: When artist refuses to give a balloon to a child less than three years of age, client cannot force artist to do so).

**Entertainment** – If artist has closed the line because the event has ended, no more customers will be added to the line.

**Rain, Wind or any other Inclement Weather** – For the comfort of your guests that are standing in line and the artist, the client agrees to provide adequate area and shelter for artist to work; indoors this means a minimum 6' X 6' clear space; outdoors this means an area with a 6' X 6' minimum level surface, and protection from the elements (extreme temperatures, sun, rain and excessive wind in particular. Client is responsible to provide an alternate indoor location in the event of inclement weather where the temperature falls below 50 degrees Fahrenheit, or above 90 degrees Fahrenheit.

The client agrees to pay the **full amount** contracted for once the entertainment has arrived at the event location, even if it is raining and the entertainer cannot perform.

**Rain Date** – The client may choose a rain date, but that date will have to be mutually agreeable. The client must notify Fancy at 404 797-5454 (Please do not leave a voice mail, but rather speak with the entertainer) at least four (4) hours prior to the time of the event if they wish to exercise this option. **Parking** – When possible, client is responsible to provide entertainer with a parking space close to the event location, as entertainer has many supplies to transport. Client is responsible for providing to entertainer a complimentary parking pass prior to the event or compensation for any entrance or parking fees.

**Change Location after Set-up** – If the client requests a change in location once the entertainer has set up, the time required to reset is counted as part of the contracted time.

**Payment Arrangements** – I have received your non-refundable \$ \_\_\_\_\_ deposit for the above-mentioned entertainment. The final payment of \$ \_\_\_\_\_ is due the day of the event.
